National Health Commission Office (NHCO)


The National Health Commission Office (NHCO), Thailand is an autonomous government agency under supervision of the Prime Minister. The National Health Act (A.D.2007) defines the role of NHCO as a facilitator for policy process which underlines inclusive participation and evidence. We provide platforms, tools and processes to multiple stakeholders for co-design, co-produce and co-benefit of public policies.

Our vision is to develop the health system by a participatory public policy process based on wisdom. (4P-W)

National Health Commission

The National Health Commission demonstrates a participatory governance for health in Thailand. The composition of the commission represents Thai's concept of work "triangle that moves the mountain" which the synergy of knowledge power, political power and social power can solve complicated and complex problems. NHCO is a secretariat of this commission.

We provide platforms, tools and processes to multiple stakeholders for co-design, co-produce and co-benefit of public policies.

Health Assembly is a process and platform for a policy process, that engages multi sectors to brainstorm and dialogue for policy recommendation and solutions.

We organize the National Health Assembly annually and encourage our partners to organize Provincial Health Assembly and the issuedbased health assembly.

Health System Charter is a blueprint for the desirable health system jointly developed by a health and non-health sector.

Apart from the National Health System Charter, local governments and other organizations can develop their health charter for their context, e.g., a health charter for Mon ethnic group, a health charter of schools led by Ministry of Education, a health charter of monks led by The Sangha Supreme Council of Thailand.

Health Impact Assessment

is a process of collectively assessing impacts on health and wellbeing from policies, programmes and projects. Scientific and lived evidences from HIA aims to inform decision-making.

HIA Commission set a HIA system and develop guidelines for all stakeholders to co-conduct HIA.
